**SPECIFICATION, SCOPE OF WORK AND MAP**

**A) Project title: Project to Support for improving corn cultivation in the Mukumbi Group**

**B) Brief project description:** This agricultural assistance project is part of the dynamic of improving the well-being of the community of the Mukumbi group affected by the mining activities of the company Lualaba Mining Ressources SAS. Specifically, this project consists of distributing improved corn seeds as well as chemical inputs (fertilizers and pesticides). It will also be a question of technically supporting the farmers of the Mukumbi group through various training courses for their capacity building on modern techniques with a view to increasing corn production. Around 300 hectares of corn will be affected for the entire area affected by the mining activities of Lualaba Mining Ressources SAS.

In this program, the beneficiary population will be constituted and organized into peasant organizations (POs) for effective assistance and good results. The organizational approach of POs has been demonstrated to have a positive impact on agricultural development in rural areas through the improvement of the socio-economic situation of communities

**C) Beneficiaries:** The beneficiaries of this project are the farmers of **four villages in the Mukumbi group, namely: Kampemba, Kawama, Sandra and Mukumbi..**

**Around 750 family will directly** benefit from this project, or an average of 4,500 people, through direct training, their participation in implementation activities and the provision of in-kind contributions (seeds and chemical inputs).

**In addition, more than 1,500 other families** living in the targeted area of the Mukumbi group will benefit from the induced effects of the project, such as access to quality maize and increased food availability but also through related activities such as marketing, processing, field labor, etc

**D) Implementation strategy and methodology**

a) In total, **750 households from the four aforementioned villages to be selected and invited to an exchange and training workshop before implementation of the project.**





b) Farmer organizations (OPs) made up of **25 family** each will be set up following the **agricultural village approach and composed of a management structure (president, vice-president, secretary, treasurer, as well as members)** which will be voted on by pairs. An area of 10 hectares will be allocated to each PO, in addition to related inputs (seeds and chemical inputs). Contractor will make available to each PO: 250 kg of corn seed, 2.5 tonnes of NPK fertilizer (10-20-10), 2 tonnes of urea (46%), and pesticides.

c) At the end of each campaign, a reimbursement in kind on the production will be made by the beneficiary PO in order to ensure the sustainability of the project. Practically, a quantity of 800 kg of dry corn per hectare as harvest product will be reimbursed by the beneficiary PO. The CLD will be responsible for monitoring, collecting, packaging and storing grain corn reimbursed. This reimbursable corn which will be kept and managed by the CLD will constitute a source of financing for the next agricultural seasons.


#### **E) Criteria for the selection of the beneficiary:**

The criteria for selecting beneficiaries include:

- o Be resident in one of these neighborhoods;
- o Not have support from another project or organization or NGO for agricultural inputs;
- o Be of good character and have a good testimony;
- o Be an active farmer, i.e. have a field in use during 2 previous growing seasons;
- o Have at least 0,5 ha of space on the indicated section.

#### **F) Expected results**

- ✦ The distribution of agricultural inputs for an area of 150 ha carried out (each year 30 ha);
- ✦ Poverty, unemployment and food insecurity are decreasing;
- ✦ Corn production in the KAMBOVE territory increased;
- ✦ Sustainable jobs created and incomes increased.






