The project also intends to provide support to breeders by providing them with technical support in terms of training and supervision (proximity monitoring) of breeding activities within households.



SPECIFICATION, SCOPE OF WORK AND MAP

A) Project title: Project to Support for the goat and chicken farmers of the pulpits.

B) Brief project description: This project consists of distributing of livestock to 250 selected households/ family in the villages of Mukumbi, Sandra, Kasansama, Kawama, Kakonde, Lumba-Kinsense, Makungu of the Mukumbi grouping.

The below supports to be given to the selected households/families: -

1. Poultry (chicks) and animals (goats) at the rate of 100 improved chicks per family and 10 brood goats per group of 10 farmers including 8 goats and 2 goats
2. Agri-veterinary products for animal and poultry care
3. Livestock equipment.

The project also intends to provide support to breeders by providing them with technical support in terms of training and supervision (proximity monitoring) of breeding activities within households.

C) Beneficiaries: The beneficiaries of this project are the livestock-producing households/families of **Mukumbi (50), Sandra (10), Kasansama (10), Kawama (10), Kakonde(10), Lumba-Kinsense(10) and Makungu (10).**

- ✓ **Direct beneficiaries:** 250 livestock-producing Households/families in the above village
- ✓ **Indirect beneficiaries:** clients and other organizations or services that will be added to this activity.


D) Project Objectives

General objective

- ✓ Contribute to the promotion of food security and the development of sustainable agriculture.

Specific objectives.

- ✓ Improving the practice of breeding in the country by introducing



- improved chick strains and pig breeds,
- ✓ Improving community diets through access to animal protein .
- ✓ Diversify sources of household income and increase them through market access.

E) Expected Results

- ✓ **The practice of breeding in the country is improved.**

Indicators: introduction of improved strains and breeds of chicks and pigs; technical support to households; adoption by households of resilient farming practices; increase in poultry and pig meat production in the country (1 000 goats of 80 kg standing each produced within 5 years);

- ✓ **The food supply to the communities is improved.**


Indicator: frequency of meat consumption in households.

- ✓ **The sources of income are diversified and the increase in income is assured.**

Indicators: Livestock practice combined with other subsistence activity in a household: rate of increase of family income with livestock practice.

F) Activities to achieve results.

- ✓ Provide technical support (state expertise) for livestock farming,
- ✓ Identify breeders in Mukumbi, Sandra, Kasansama, Kawama, Kakonde, Lumba-Kinsense, Makungu of the Mukumbi grouping;
- ✓ Acquire chicks, pigs, agri-veterinary products and livestock equipment;
- ✓ Organize training sessions on husbandry techniques, financial management of a breeding activity and on working with breeders' associations;
- ✓ Distribute inputs, agri-veterinary products and livestock equipment;
- ✓ Monitor and evaluate livestock activities with households;
- ✓ Organize sessions for sharing experience between breeders;
- ✓ Conduct a final project review session.



G) Project Implementation strategy

- ✓ Funding and project management provided by LMR;
- ✓ Identification of beneficiaries by Proposed Consultant with the help of LMR in collaboration with chieftaincy technicians (AGRI and DERU) and community representatives from 7 villages;
- ✓ to take in to account Gender balancing in the selection of direct beneficiaries of the project;
- ✓ Provisions of breeding areas to be used by the selected breeders at their expenses;
- ✓ Support by LMR of chicks, goats, agro-veterinary products and livestock equipment;
- ✓ Training and other technical support, including supervision and monitoring.
- ✓ For pig breeding, the broodstock roaming system will be applied, the first 100 beneficiary households will reimburse LMR for 100 breeders after 2 birth, which will be redistributed with appropriate techniques in order to avoid inbreeding. After six birth, the first 100 households returned 250 goats at the rate of 200 goats and 50 goats for the subsidy of the last 50 households.
- ✓ To avoid any recovery of the project, criteria defined to benefit from project support

H) Criteria for the selection of the beneficiary:

The criteria for selecting beneficiaries include:

A. For chicken farmers:

- ✓ Have lived in targeted villages for at least 3 years;
- ✓ Be recognized as a breeder of native chickens for at least 2 years;
- ✓ Have a good testimony of at least 4 people living in the village concerned .
- ✓ Not have other support from other projects of the same nature.

B. For goat breeders :

- 1) Be a resident of the targeted villages for at least 3 years;
- 2) Be recognized as a breeder of native chickens for at least 2 years;
- 3) Be a member of the breeders' cooperative formed by the DERU;
- 4) Have already prepared a home (pigsty) for the pigs.


